2.1. **Movements:**

3. **Facilitation Principles:**

3.1. Flights to be facilitated:

- In accordance with the amended EU-Regulation 95/93 and Regulation 155/2008 issued by the 3.1.1 Ministry of Transport, Innovation & Technology of Austria, all schedule and planned charter flights have to be facilitated.
- Due to capacity restrictions also positioning flights (service type "P"), technical flights (service 3.1.2 type "T"), training flights (service type "K") and technical stops (service type "X") have to be facilitated and will be proved against the relevant capacity.

3.2. Flights not to be facilitated:

- 3.2.1 General Aviation Flights (Codes "D" and "N"); governmental flights (service type "E"); ambulance -, rescue - or humanitarian flights (service type "U"); state or diplomatic flights (service type "I") and military flights (service type "W").
- Operationally required ad hoc flights within the following 48 hours. This rule does not apply for 3.2.2 flights with service type codes "C", "G" and "J".

 Operationally required changes of already facilitated flights within the next 48 hours. This rule
- 3.2.3 does not apply for flights with service type codes "C", "G" and "J".
- 3.2.4 However, the airport operator has to be informed about the above mentioned flights in advance.

4. Submission of schedule requests:

- Schedule requests have to be sent in SSIM Chapter 6 format either by 4.1.

 - OCS (Online Coordination System).



5. Minimum Ground Times (MGT):

- **5.1.** Minimum ground times have to be cleared and confirmed with Graz Airport (operationsoffice@graz-airport.at).
- **5.2.** Handling requests have to be cleared and confirmed with the handling agents available at Graz Airport.
- **5.3.** The following table should give you an indication of the minimum ground times at Graz Airport:

AC-size	MGT in Minutes
Up to 80 seats	15 – 30
Up to 200 seats	40 - 60
Up to 350 seats	60 – 90
More than 350 seats	120
