Swap / Transfer of Slots at Coordinated Airports in Austria

Regulation (EEC) 793/2004 of the European Union, dated April 21, 2004 amending Regulation 95/93 (the Slot-Regulation) stipulates that air carriers have to submit all relevant information in the format and time limit requested by the coordinator.

Communication (KOM (2008) 227, dated 30. April 2008) of the Commission states in Para 5 that "However, the Commission recognize that exchanges of slots for monetary and other consideration, more commonly referred to as "Secondary Slots Trading", are taking place at a number of congested community airports. The Commission does not intend to pursue infringements proceedings against member states where such exchanges take place in a transparent manner expecting all the other administrative requirements for the allocation of slots set out in the applicable legislation".

The Slot regulation defines in Art. 8A the conditions for slot mobility.

In edition 1 of the WASG the framework for swapping or transferring of slots between airlines was reworded in para 8.11, 8.12 and 8.13.

In accordance with the Austrian Civil Aviation Authority all air carriers, wishing to swap or transfer already allocated slots at a coordinated airport in Austria, are herewith requested to inform Schedule Coordination Austria in writing of the swap or transfer of allocated slots and to send a copy of the slot swap/transfer agreement to Schedule Coordination Austria to register the operational parts of the swap or transfer.

This procedure for slot mobility at coordinated airports in Austria will becomes

effective as of March 18th, 2022

until further notice

and replaces all previous forms.
